#### Guidelines 附錄

#### Guideline 1: Company Name 附錄 1: 公司名稱

Company name can be either in English, Traditional Chinese or both 公司名稱可以用英文,繁體中文或中英同用

● Company name must end with "Limited" 公司名稱最後必須是『有限公司』

Company name must be unique 公司名稱不可以於其他公司相同

#### Guideline 2: Registered Capital 附錄 2: 註冊股本

You are forming a private company limited by shares, meaning the liability is limited to the assets of the company and the value of the issued shares. 你現在成立一間持有限股本的公司,公司債務將不多於貴公司的資產及發行股本的價值。

Registered capital or sometimes referred as share capital, is not the minimum balance in your bank account. 註冊股本不等於公司於銀行開戶的最低存款數目。

The minimum registered capital is HK\$1. 註冊股本最少為 HK\$ $1 \cdot$ 

#### Guideline 3: Company Secretary 附錄 3:公司秘書

If the company has only 1 director, this director cannot also act as the secretary. 如公司只有 1 位董事,該董事不能同時兼任秘書。

Good Faith Asset Management Company Limited offers Company Secretary Package which includes acting as your company secretary, board meeting minutes and submitting annual return. 聰誠資產管理有限公司提供公司秘書套餐,可以代替出任公司秘書,編寫周年股東大會會議 記錄,呈報本周年年報。

#### Guideline 4: Registered Address 附錄 4: 註冊地址

Registered address is your official address where the government communicates with you. 註冊地址是你的官方地址,政府機關會主要以書信方式寄到註冊地址。

This address is shown on your business registration certificate and the Companies Registry's public database. 註冊地址會印在商業登記證上以及在公司註冊處查冊得到。

Must be a valid address in Hong Kong, PO Box is not accepted. 註冊地址必須是有效的香港地址亦不能是郵政信箱。

#### Guideline 5: Director, Shareholder 附錄 5: 董事,股東

Starting in 2014, each company must have at least 1 individual director. 2014年起,公司必須要有一位個人董事。

A corporate shareholder is a limited company that owns shares. Similarly, a corporate director is a limited company acting as a director of the company instead of a real person. 公司股東是指一間公司持有另一間公司的股份,公司董事是指董事由一間公司出任。
